\*Our Company had availed a term loan from Yes Bank Limited for an amount aggregating to ₹ 5,000 lakhs which was repayable in 39 quarterly instalments commencing from December 2016 and ending on June 2026. In the Draft Letter of Offer, our Company had disclosed that it proposed to utilize an aggregate amount of ₹ 1,500 lakhs from the Net Proceeds towards full or partial re-payment or prepayment of the secured loans availed by our Company from Yes Bank Limited. ## INTERNAL RISK FACTORS

## The below mentioned risks are the top five risk factors as per the Letter of Offer:

- The Net Proceeds will be utilized by our Company and our Subsidiaries towards repayment or prepayment of loans availed by our Company and our Subsidiaries and accordingly, the utilization of the Net Proceeds will not result in creation of any tangible assets. Further, our Promoters have significant control over the Company and have the ability to direct our business and affairs; their interests may conflict with your interests as a shareholder.
- 2) Due to the seasonal nature of the industry, we operate in, we may not be able to achieve complete utilisation of the windmills owned and operated by our Company, which in turn could materially and adversely affect our business, prospects, financial condition and results of operation;
- 3) Our operating projects are located in four states in India and expanding into other states poses risks;
- 4) Net Worth of certain of our Subsidiaries has experienced consistent fall in the preceding three years. Further, two of our Subsidiaries, namely Amrit Environmental Technologies Private Limited and Orient Green Power D.O.O are no longer operational. Our Subsidiary, Orient Green Power (Maharashtra) Private Limited has been struck off and therefore is no longer in existance and, Amrit Environmental Technologies Private Limited has defaulted in repayment of a loan availed from IL&FS Financial Services Limited; and
- 5) One of our Subsidiaries, Amrit Environmental Technologies Private Limited, has defaulted in repayment of a loan availed from IL&FS Financial Services Limited.
